

BANN ROWING CLUB PRIVACY NOTICE FOR MEMBERS

We at Bann Rowing Club want to make sure all the personal details we hold about you are safe and secure, so we have put together this note to tell all of our members/parents or guardians, whether you are a rower or simply a fan of the sport, how we make sure we just do that and what to do in case you have any questions for us or want to see what information we have. We are, what is known as, **a data controller**. This means we have control over how your details are used and who we pass them to.

Sometimes organisations like ours need to appoint an individual called a "Data Protection Officer" to make sure that we are being very careful with your information. We don't need to have a Data Protection Officer, but we have decided to put together a team of people instead to make sure your details are safe. 1. WHAT TYPE OF DETAILS DO WE COLLECT FROM YOU?

We might collect the following personal details about you before, during or after your time as a member, such as;

- o details of how we can contact you, your name, email address, where you live and phone number;
- o your birthday; the name of the school you attend.
- your gender;
- o membership details including when you signed up to be a member and any date you decide to leave us;
- o all records of when you contacted us or we contacted you on the phone or by email or when you asked us to do something;
- any bank details belonging to your parent or guardian so that we can receive payments from you and details of any payments you make;
- how you use our website and any passwords, user names and other things that may identify you to us online;
- records that tell us when you were at events or competitions;
- o videos and photos of you;
- o your passport or other ID cards;
- o records of whether you compete at national or international level.
- o details of family members, coaches and other people we might need to contact in case of an emergency;
- o records of your rowing status, including any competition results, what events you have attended and how well you are performing on any development programme or trials you are registered on,
- o any disciplinary information or details of any issues you have with us or we have with you.

2. SPECIAL CATEGORIES OF PERSONAL INFORMATION

We may also hold and use what is called "**special information**" such as, whether you have any religious beliefs and any information about your health such as any injuries you have/have had or times you may not have been very well. In the table below, where we use this **special information** you will see we will only use it if we have a really good reason to do so such as:

- o if it is in the interests of the public and we have a lawful reason to use it;
- o we need it to help us with a legal case we are involved in;
- o certain laws allow us to use it; or
- o you have told us you are happy for us to use it.

In the table below we refer to these as the "special reasons".

3. WHERE DO WE GET THIS INFORMATION FROM?

We will normally collect personal information about you when you become a member of Bann Rowing Club or when you want to talk to us on the phone, by Email, Text, Messenger, What's App or Facebook or in some other way.

4. HOW DO WE USE YOUR INFORMATION?

In some cases we might need the information you have given us to make sure we can do what we say we are going to do with your details. Other times, we may not need it, but if we don't have it, we may not be able to provide you with the best possible service.

If you have told us we can use your information in a certain way, you can tell us to stop using it at any time, by contacting your Coach.

5. HOW CAN YOU STOP US FROM MARKETING TO YOU?

Sometimes we may wish to contact you by Email, Post, Text, Messenger, Facebook or What's App to tell you about things we think you might like. We will only do this if you have told us you are happy to receive these messages and you can tell us to stop at any time by letting us know.

6. WHO ELSE MAY USE YOUR DETAILS?

We may send your details to others to help us run our organisation. These are:

- o Anyone you have said you are happy for us to send your details to.
- o **To any regional or governing body:** to help us to improve and keep an eye on developments in the sport, eg, Sport NI and Rowing Ireland
- o The Government or our regulators: where the law tells us to do so or to help them with any investigations.
- Police, law enforcement and security services: to help them with any investigation, prevention of crime or matter of national security.

7. ARE YOUR DETAILS SAFE?

We have put in place lots of security measures to make sure your details don't go missing or get used in a way they shouldn't be. We have a great team of people working with us who are trained to know how to use your details securely and will only use your details when and how we tell them to.

Did you know that all 'data controllers' based in the European Union and the UK like us are subject to laws that make sure that your personal details are safe;

8. HOW LONG DO WE KEEP PERSONAL INFORMATION FOR?

We collect personal details from you for different reasons and so we might keep it for different lengths of time. For example, we might have to keep it for a long time for legal reasons, but most of the time, we will keep your details for 3 years after your membership has ceased.

It is important to make sure that the details we hold about you is accurate and up-to-date, so make sure you let us know if anything like your email address or phone number changes. You can normally do this by giving the information to your Coach or Club Treasurer.

9. WHAT ARE YOUR RIGHTS?

Did you know you can ask us to do lots of things with your details?

You can ask us:

- o to tell you how your details are being used;
- o to provide you with a copy of all details we hold on you;
- o to correct some of the details we hold if they are not correct or out of date like your contact details for example;
- to delete all of the details we hold on you (unless we have a good reason not to!);
- to stop using your details in a certain way;
- o to send your details to you or another organisation like any other sports club you may belong to;
- o to stop making decisions about you using automated technologies which analyse your personal details e.g. performance software

Some of the rights may not always apply to the personal details we hold for you as there are sometimes requirements and exemptions which means we need to hold on to certain information and other times the rights may not apply at all.

DON'T FORGET though, if you have told us we can use your information in a certain way and you would like us to stop, you can tell us to stop at any time and you can always tell us to stop sending you marketing messages. 10. WHAT HAPPENS IF WE NEED TO CHANGE THIS NOTICE?

Keep an eye out for changes to this notice online. If we make big changes the version date at the bottom of the notice will be updated. Of course where we are required to do so by law, we will ask for your permission before we change the reason for using your details.
